This has reference to your application Id No. **9485-14-09-2024** seeking accreditation by National Board of Accreditation (NBA) to the UG Pharmacy program applied by **Seven Hills College of Pharmacy, Venkatramapuram Village, R C Puram Mandal, Chittoor District, Tirupati – 517561 Andhra Pradesh.**

2. An Expert Team conducted on-site evaluation of the program from 04<sup>th</sup> to 06<sup>th</sup> April, 2025. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The Competent Authority in NBA has approved the following accreditation status to the program as given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The program has been granted accreditation for three years. **Seven Hills College of Pharmacy, Venkatramapuram Village, R C Puram Mandal, Chittoor District, Tirupati – 517561 Andhra Pradesh** should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.

The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **Seven Hills College of Pharmacy, Venkatramapuram Village, R C Puram Mandal, Chittoor District, Tirupati – 517561 Andhra Pradesh** as a whole.
